





The Vitality Gym Series terms and conditions

- 1. The promoters of the competition are Discovery Vitality (Pty) Ltd ("Discovery Vitality"), Planet Fitness South Africa and Virgin Active South Africa ("Vitality gym partners") ("gym partner").
- 2. The Vitality Gym Series competition ("the competition") will take place at Virgin Active and Planet Fitness health clubs across South Africa, excluding the Virgin Active Collection Clubs. The event will run at each partner separately. Participants will choose the partner they prefer.

3. Competition Period

The competition will take place on 3 and 10 September 2022.

- 3.1. Round 1 of the Vitality Gym Series will take place on 3 September 2022, between 8:00 and 14:00 depending on the time slot chosen by each participant upon entry.
- 3.2. Entries to round 1 will close on Thursday, 1 September 2022 at 11:59.
- 3.3. Participants that make it to the top five of their respective categories, will compete in the Vitality Gym Series final round which will take place on 10 September 2022 from 9:00 until 16:00.

4. Who is eligible?

- 4.1. Any person living in South Africa aged 18 years or older, with a valid South African ID number or passport number, can enter on the Vitality Gym Series online entry page from 10 August 2022 to 2 September 2022 at 23:59 to compete.
- 4.2. Vitality premium and Vitality Active members with an active Vitality gym benefit or gym membership at Virgin Active or Planet Fitness who have chosen to participate in the competition at their respective gyms can compete for free.
- 4.3. Vitality premium, Vitality Active members who do not have an active Vitality gym benefit at Virgin Active or Planet Fitness can pay using Vitality Pay as you Gym to compete or choose to pay the chosen gym's normal guest fee for the day to compete.
- 4.4. Members of the public who do not have an active gym membership with either gym partner will need to pay the chosen gym's normal guest fee for the day to compete.

5. How to Enter

5.3. Only one entry per person will be accepted and no changes maybe made to an entry, once the entry number has been issued.

6. What are the Prizes?

Round one

- 6.1. Each participant will be added to the leaderboard with the total number of reps across all exercises next to their name Winners will be selected based on this total number of reps completed within the allocated period of 8 minutes.
- 6.2. The first five people with the highest total number of reps per category (top 5) will win round one of the Vitality Gym Series and qualify for the final round. This means the total number of finalists will be 30 finalists for Virgin Active and 30 for Planet Fitness They will each receive a Vitality Gym Series limited edition t-shirt.
- 6.3. Any top 5 category finalist who lives outside of Gauteng and more than 200 km away from Sandton, Johannesburg, will be transported to Sandton through our Vitality Travel benefit.

Round two (Final round)
