



Vitality and Huawei August 2022 gym competition terms and conditions

- 2. The competition will run from 1 August 2022 until 23h59 on 31 August 2022 at Virgin Active and Planet Fitness.
- 3. Entrants into the competition are required to reside in South Africa.
- 4. The competition is open to Vitality Premium members over the age of 18 years old.
- 5. To participate and get into the competition prize draw, qualifying Vitality members need to:
 - 5.1. Have an active Vitality Premium membership.
 - 5.2. Have an active Vitality gym benefit at Virgin Active or Planet Fitness during the competition period.
