

# Shell motorsport campaign terms and conditions

- 3. Who can enter:
  - a. You must live in South Africa and be 18 years or older.
  - b. You cannot enter if you are a director, member, partner, or a supplier of any goods or services in connection with the competition.
  - c. You also cannot enter if you are the spouse, life partner, business partner, or immediate family member (parent, child, or sibling) of anyone mentioned in (b).
  - d. You must have a valid driving licence and a valid passport.
- 4. By entering this competition or accepting a prize, you agree to these terms and conditions, as well as any additional terms for the prize.
- 5. Any information about this competition published by Discovery (like promotional materials) is part of these terms and conditions.

#### How the competition works

- 6. The competition starts on 20 January 2025 at 00:00 and ends at 23:00 on 31 March 2025. Entries received outside of these dates and times will not be valid.
- 7. If you are a Discovery Insure client with Vitality Drive, fill up **five times** at Shell for R750 or more and swipe your linked Vitality Drive card.
- 8. If you are a Discovery Insure client who does not have Vitality Drive, you will need to activate Vitality Drive on your plan, then install your telematics device and link your Vitality Drive card. Then, fill up **five times** at Shell for R750 or more by 31 March 2025. Swipe your linked Vitality Drive card.
- If you are not an existing Discovery Insure client before 20 January 2025 you need to get an obligation free car insurance quote (you are not required to activate a policy). Fill up at Shell for R750 or more and keep your receipt for validation of entry.
- 10. One of four people will win a ticket for themselves and a friend to an all-expenses-paid trip to Spain.
- 11. Each person will receive one entry into the competition if they complete the requirements listed in point 7 or 8 or 9.
