

Terms and conditions for the Vitality Cardio Fitness Social Media competition

 <u>Africa (Pty) Ltd (Garmin)</u>.
- 2. The competition will run from **15 August 12 September 2024**, with a deadline for entry at midnight on 12 September 2024.
- 3. The competition is open to qualifying Discovery Vitality Health and Vitality Active members.
- 4. Entrants need to be the main member, spouse, adult dependants, or child dependants over the age of 18 (eighteen) years on the Vitality policy.

 - 7.3 The Garmin fitness device prize will be a <u>Forerunner 165</u> (valued at R6,499). Winners can select the colour preference subject to availability.
