# **Discovery Bank Home Loan and associated ancillary products**

If you are not the Discovery Bank Financial Adviser on record, initiate a linkage request via the Discovery Bank Financial Adviser Platform. The client will provide consent through their Discovery Bank app to complete the process.

#### 1. Fees

The Financial Adviser will earn a **once-off fee of between 0.1% and 0.3% of the final home loan limit granted.**The Financial Adviser may also earn **a once-off referral fee of up to 80% of the first year's premiums** on take up of a Discovery Life Home Loan Protector.

Fees payable to the Financial Adviser are payable by Discovery Bank and not by the client.





## 2. Important information

- You need to be a qualifying Discovery Bank client at the time of applying for a Discovery Bank Home Loan.
- Cancellation fees may apply on early settlement of a Discovery Bank Home Loan.
- The Financial Adviser should ensure the client has a copy of the completed Record of Services form.

#### 3. Client mandate and consent

- I request, consent to and hereby authorise my Financial Adviser (including their authorised assistant, or any duly authorised person(s) within the same FSP or intermediary house) to dispute any credit decisions made by Discovery Bank Limited on my behalf; and
- I hereby waive any and all claims against Discovery Bank Limited in this regard, and will not hold Discovery Bank Limited responsible for any direct or indirect loss, damage or costs arising from the performance or non-performance of this consent.
